About the Symposium April 27, 2016 in Lakewood, WA

- Originated from the Transportation and Disaster Resilience Sessions at last year's PNWER Summit in Big Sky, Montana.
- Organized by PNWER's Center for Regional Disaster Resilience and Transportation Co-Chairs Bruce Agnew and Senator Chuck Winder





About the Symposium

- Over 200 participants attended the event, including nearly 20 elected officials
- In attendance:
 - Local, state, and federal emergency management
 - Railroad and industry leaders
 - Port commissioners and representatives
 - State and federal regulators including the FRA, Department of Ecology, and the EPA



About the Symposium

- Agenda topics included:
 - Setting the Stage: From Bakken Oil Fields to West Coast Refineries
 - Federal Regulations: Current and Proposed
 - Emergency Management and First Responders
 - Ecology Spill Response: Local Capacity and Capabilities to Respond
 - Public Officials Response





Since the Symposium...

- June 3, 2016: Oregon Columbia River Gorge Oil Train Derailment
 - Spilled 42,000 gallons of Bakken crude oil and sparked a fire that burned for 14 hours
 - Reactions from state elected officials, local first responders, and federal lawmakers
 - Governor Kate Brown calls for moratorium on oil trains in Oregon State & Governor Jay Inslee calls for temporary halt on Union Pacific oil trains in Washington State
 - Oregon Senators Merkley and Wyden introduce new oil train legislation to United States Senate
 - Industry Response (BNSF "Inside Tracks")

Recommendations

- Based on the discussion and feedback from participants, the following recommendations were developed:
 - Raise awareness for legislators and rail communities by developing a single repository for oil (and other HAZMAT) train safety information
 - Connect Northwest and Canadian rail corridor communities to share best practices with industry and regulators (Contingency Plans)
 - Encourage Class One and short haul railroads and shippers use the best technology for track inspection, operations, spill mitigation, and restoration
 - Pursue federal funding to expand PNWER's legislative and congressional public education and outreach on rail safety



Next Steps

- PNWER will continue to discuss oil train safety in more detail at the 2016 Winter Meeting in Boise, Idaho and the 2017 Annual Summit in Portland, Oregon.
- In the meantime, PNWER's Transportation Working Group will pursue federal support and resources to help outreach and bring together regulators and industry from throughout the entire corridor
