He was first elected to the legislature in 2014, and currently serves on the Community & Regional Affairs, Education, and Resources Committees. David was born in Ellensburg, Washington and moved to Suntrana, Alaska, a mining

community next to Healy, when he was 13 years old. He served on the Upper Railbelt School Board from 1976 to 1977 followed by the Denali Borough Assembly from 2001 to 2002. From 2002 to 2012 he was also the longest serving mayor of Denali Borough. He has worked in the mining industry for approximately 25 years, holding a variety of positions such as warehouseman, heavy equipment operator, production supervisor, human resource director, and safety director to name a few.
