Cross-Border Economic Leadership Forum to be Held in Portland, Oregon, December 4-6

State and provincial legislators and business leaders from Western Canada and the Pacific Northwest states will convene in-person and virtually at the Pacific NorthWest Economic Region's (PNWER) Economic Leadership Forum in Portland, Oregon, on December 4-6, 2022. This bi-national hybrid event will bring together delegates from the PNWER U.S. jurisdictions of Alaska, Idaho, Montana, Oregon, and Washington, and the Canadian provinces and territories of Alberta, British Columbia, Northwest Territories, Saskatchewan, and the Yukon. Delegates will meet at the Hilton Portland Downtown and virtually to discuss North American energy security and sustainability, regional infrastructure, supply chain issues, broadband accessibility, disaster resilience, and more.

- Highlighting the importance of public-private partnerships in the U.S. and Canada with a specific focus on transportation and affordable housing
- Regional roundtable discussion on key legislative priorities for 2023 sessions
- Increasing accessibility to reliable, affordable broadband

- Aligning utility business models with transportation electrification goals
- Exploring regional and equitable infrastructure investment to plan strategically for the future of the regional economy
