2011 Beyond the Border

Key Accomplishments:

- LMRA – *Negotiated an expanded Preclearance Agreement.*
- Pilots – *Cargo pre-inspection pilots at land borders; Known employer pilot for business travel and cross border work*
- Data Sharing – *Sharing of each country's 'No-Fly' lists; Visa and Immigration information sharing.*
- Entry Exit – *Joint entry/exit initiative sharing entry/exit movements at land borders (planned expansion 2018)*
- ESTA/eETA/IAPI – *Development and use of interactive and electronic travel authorization systems*
- Law Enforcement – *Joint cross border law enforcement improvements and mutual recognition of security processes*

A New Perimeter Vision Needed

- **Strengthening Border Security:**
 - Pre-Border, at Perimeter and at Shared Border
- **Process Convergence & Risk Management:**
 - “Free” movement of pre-screened travelers and goods
 - Expedited Movement for Low Risk travelers and goods
 - More Integrated Processing: inter-agency, between governments and with industry partners using information technology & Biometrics
- **Greater economic prosperity & competitiveness**
- **Maintaining Sovereignty & Privacy Policies**

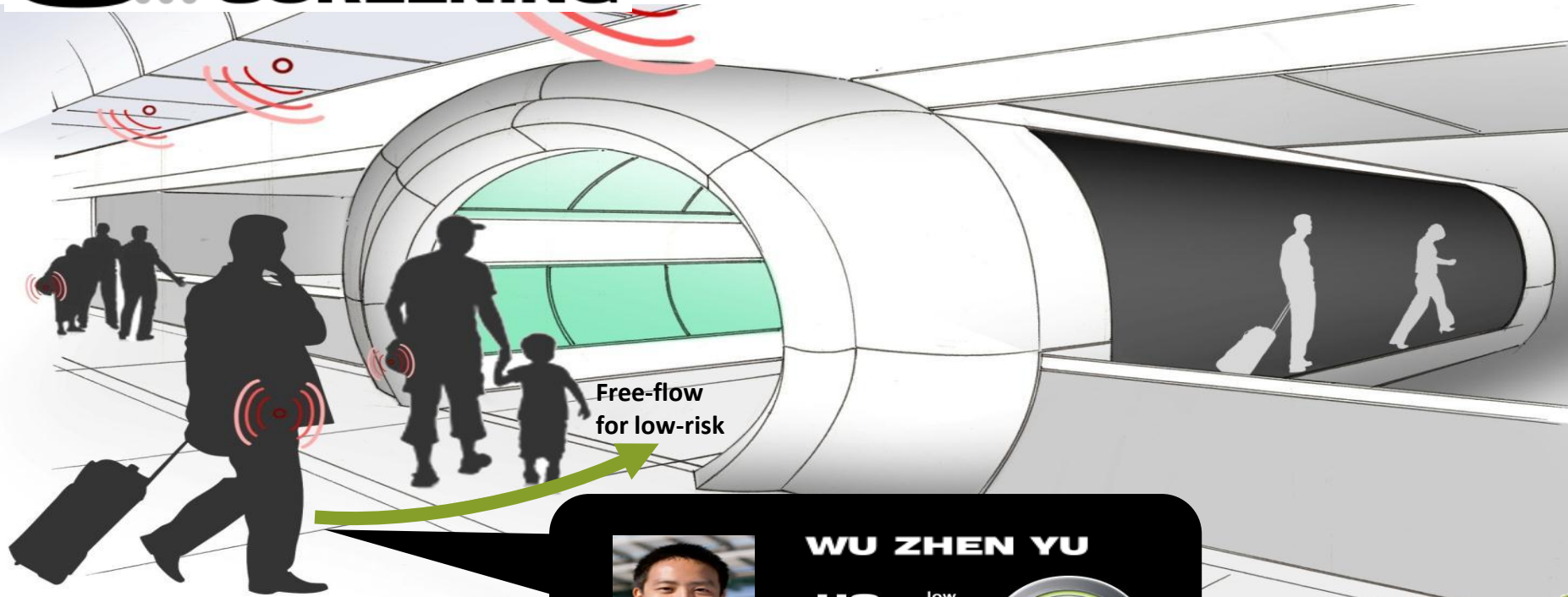

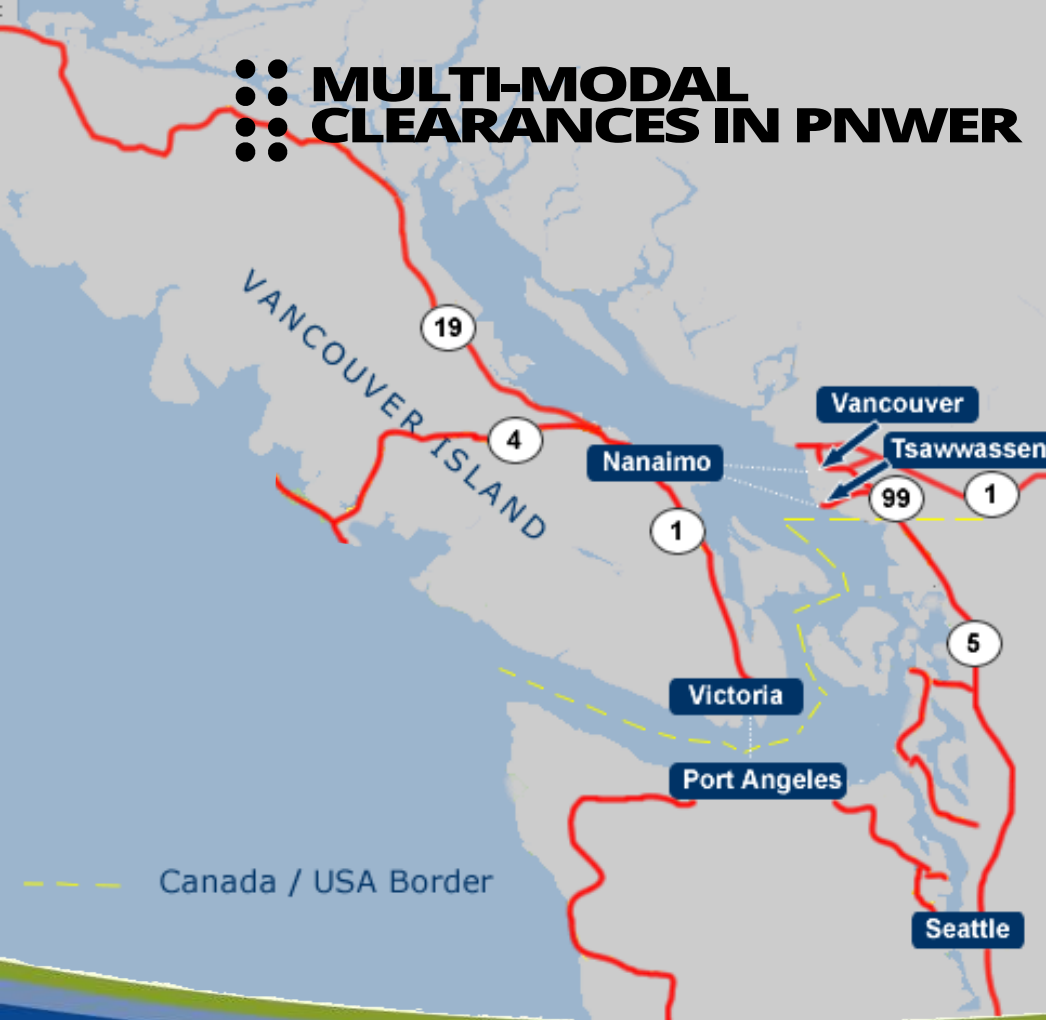
